That the Board of Education authorize the Superintendent or his designee to purchase software subscriptions, professional services, and support services from Integrity Schools and Skward, Inc. to implement the School Interoperability Framework (SIF) between the Skyward HR system and Microsoft Active Directory at a cost not to exceed \$17,500 in fiscal year 2017, and with an increase of \$4,400 in annual support and licensing cost beginning in fiscal year 2018.

Rationale

Currently, employee status changes, e.g., hire, name change, assignment change, leave, termination, etc., are processed manually in both Skyward (HR/payroll) and in Microsoft Active Directory (network and system accounts). This process involves redundant manual data entry in the two systems which is inefficient and increases the likelihood of data entry error. By contrast, student data is seamlessly and automatically transferred from PowerSchool to Active Directory (AD), Destiny Library, and Nutrikids Food Service systems using School Interoperability Framework (SIF). SIF enables software applications in school districts to seamlessly share data increasing efficiency, reducing data entry effort, and improving data quality.

The administration proposes to extend the District's SIF environment to include the transfer of employee data from Skyward to AD, and that Integrity Schools and Skyward design, implement, and support the expansion. Integrity Schools is uniquely qualified for this project due to its intimate knowledge of the District's data environment and its history of successful SIF implementations and support in the District.

Implementation, service, and support costs projected for fiscal 2017 are as follows:

Allowing some contingency for minor adjustments in design or scope, the total cost will not exceed \$17,500. This not-to-exceed amount will be paid with fiscal 2017 technology funds budgeted for new software purchases and consulting services.

The annual cost of SIF licensing and support will increase from \$6,900 to \$11,300 beginning in fiscal 2018. The \$4,400 increase will be incorporated into the technology budget beginning in fiscal 2018.
